Notes:

1. The above results were reviewed and recommended by the Audit Committee and approved by the Board of Directors at its meeting held on 29th May, 2026.
2. The financial results have been prepared in accordance with the Companies (Indian Accounting Standards) Rules, 2015 (Ind AS) prescribed under Section 133 of the Companies Act, 2013, to the extent applicable and in compliance with Regulation 33 of SEBI (LODR) Regulations, 2015
3. In line with IND AS 108 - Operating Segments and on the basis of review of operations being done by the senior management, the operations of the Company fall under Manufacturing of Paper products, which is considered to be the only reportable segment by the management.
4. The figures for the quarter ended March 31, 2026 and the corresponding quarter ended in the previous year, as reported in these standalone financial results, are the balancing figures between the audited figures in respect of the full financial year and the published year to date figures upto the end of third quarter of the relevant financial years. Also, the figures upto the end of third quarter had only been reviewed and not subject to audit.
5. Figures for the previous period have been regrouped/ reclassified wherever necessary to confirm to the current periods classification
6. On 21 November, 2025, the Government of India notified the four labour codes consolidating 29 existing labour laws. The Ministry of Labour & Employment published draft rules and FAQs to enable assessment of the financial impact due to changes in regulations. The Company has assessed that there is no incremental impact of these changes on the basis of the best information available, consistent with the guidance provided by the Institute of Chartered Accountants of India. The Company continues to monitor the finalisation of Central and/ or State Rules and clarifications from the Government on other aspects of the New Labour Code and would provide appropriate accounting effect on the basis of such developments as needed.
7. Turbine of 4.5 MW is successfully installed in place of 3 MW in March 2026, with other modifications in plant and machinery which has taken the present installed capacity to 66,000 TPA.

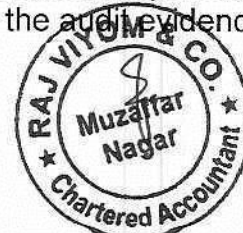

Basis for Opinion

- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by the Board of Directors.



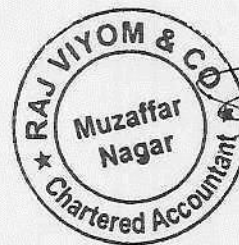
